INTERROGATORY NO. 23:

Regarding SCO's Final Disclosure of Allegedly Misused Material, dated December 22, 2005, please state with specificity – separately with respect to each version, file and line of code, method and concept identified by SCO:

- (a) by whom it has been, and currently is owned, when, and from whom it was acquired;
- (b) whether is appears in Linux and, in particular, the Linux kernel and, if so, which version(s) of Linux, and which files and lines of such version(s);
- (c) whether it was included in UnitedLinux 1.0 and distributed by SCO as part of its Linux offerings and, if so, when and to whom;
- (d) whether it was made available over the internet by SCO and, if so, when and to whom;
- (e) whether it is included in Sun's Open Solaris product and, if so, which version(s) of Open Solaris, and which files and lines of such version(s); and
- (f) whether it is included in, dictated by or related to any standards, and, if so, which ones and as of when.

RESPONSE TO INTERROGATORY NO. 23

In addition to its General Objections, SCO specifically objects to this Interrogatory on the grounds that it is overbroad, unduly burdensome, seeks information that is irrelevant and not reasonably calculated to lead to admissible evidence, and calls for information that is exclusively

a matter of expert testimony. SCO also objects to this Interrogatory on the grounds that the phrase "dictated by or related to any standards" as used in this Interrogatory is vague, ambiguous and unintelligible. SCO further objects to this topic on the ground that it seeks information that is in the possession, custody and control of IBM or third parties from whom IBM could seek such information. In particular, SCO objects to subpart (e) of this Interrogatory as it requires SCO to provide information from third party, Sun's Open Solaris product.
