**UNOPPOSED SUBMISSION REGARDING PREJUDGMENT INTEREST**

The Court's July 16, 2008 Order directs Novell "to file a brief within 15 days of this Order describing what, if any, prejudgment interest Novell seeks based on the amount awarded in this Order." At the request of the parties, the Court subsequently extended that deadline to August 29, 2008.

The Court's Order grants Novell \$2,547,817 of the monies Sun paid SCO under the 2003 Sun Agreement. (Order at 42.) The parties have reached an agreement that Novell is entitled to \$918,122 in prejudgment interest on that amount through today, August 29, 2008, plus \$489 per day thereafter until final judgment is entered.

Novell acknowledges that SCO's agreement to the amount of prejudgment interest does not grant Novell rights in excess of those afforded under the relevant Federal Rules of Civil or Appellate Procedure or applicable law.
