3. AN ORDER compelling/directing the Defendants/Respondents whether jointly or severally and each of those upon whose behalf the Defendants/Respondents are sued whether acting by themselves, their servants, agents, privies or any other person appearing to be in charge of the premises hereinafter specified, do forthwith permit the Bailiff of this Honourable Court serving this order, a Counsel from MESSRS. ADEDEJI & OWOTOMO, 18th Floor, The Buil, 38/39, Marina, Lagos, Solicitors to the Plaintiffs/Applicants herein, a Police Officer not below the rank of an Assistant Superintendent of Police or his designate, and such other persons not exceeding five (5) in number to enter and conduct a search at the premises, warehouse, shop or stall belonging to the Defendants (but not limited thereto) and situate at 60 Norman Williams Street, South West, Ikoyi, Nigeria; Plot 8, Ozumba Mbadiwe Road, Victoria Island, Lagos and 6, Amazon Street, Ministers Hill, Maitama, Abuja, FCT.

Or each part or parts thereof of the said premises, warehouse or stalls on any day of the week at any hour between 8'oclock in the morning and 8pm for the purpose of:

- i. Taking into possession and removing there from into the possession and custody of this Honourable Court or the Plaintiffs/Applicants' Solicitors (whichever order this court may deem fit to make) pending the determination of the Plaintiffs' Motion On Notice for an Order of Interlocutory Injunction or further orders, the infringing design herein defined and all invoices, bills, order forms, delivery orders and receipts in relation thereto delivered up and surrendered by Defendants/Respondents, their servants, agents or privies pursuant to paragraph 3 above, and the Plaintiffs' firm or Legal Practitioners herein named being hereby permitted to take copies thereof.
- ii. Inspecting, photographing and costing of the said infringing design and documents including photographing the Defendants/Respondents' premises, warehouse, shops, stalls or any article which may constitute evidence of the fact of infringement and or the volume of trade in the infringing design.
- 4. AN ORDER directing the Plaintiffs' Solicitors and the bailiff of this court attending the service on the Defendants of the Anton Piller order granted hereto individually and within 4 working days of the service of such order make an oath and file herein a report to such service pending the determination of the Plaintiffs' Motion On Notice for an Order of Interlocutory Injunction and further orders.
- 5. AN ORDER directing that the Defendants/Respondents and each of those upon whose behalf the Defendants/Respondents are sued whether acting by themselves, their servants, agents, privies or otherwise however, do within 48 hours of obtaining possession of any infringing design and documents as herein defined subsequent to the service of the order of the Honourable Court hereupon, to surrender them to the custody of this Honourable Court or the Plaintiffs/Applicants' Solicitors for preservation pending the determination of the Plaintiffs' Motion On Notice for an Order of Interlocutory Injunction and further orders.

AN ORDER granting leave that in default of compliance with the provision of any order made pursuant hereto by the Defendants or any of the persons on whose behalf the Defendants/Respondents are sued, or any person appearing to be in charge of the premises or stalls in which any infringing designs or materials, order MR Sforms, invoices, bills of delivery and receipts are found, the Plaintiffs/Applicants be at liberty to apply to the court for immediate committal to prison custody of any such person(s) without any further need for leave to apply for a committal order pending the determination of the Plaintiffs' Motion On Notice for an Order of Interlocutory Injunction and further orders.
