- That I am a Legal Practitioner in the Law Firm of Adedeji & Owotomo, Solicitors
 to the Plaintiffs / Applicants in this suit and by virtue of my position, I am
 conversant with the facts of this case.
- That I have the authority and consent of my employers and the Plaintiffs / Applicants to depose to this affidavit.
- That I was informed by Mr. Ade Oyegbola the 1st Plaintiff / Applicant at a meeting held in our office on November 6, 2007 and I verily believe him as follows, that:
 - (a) The Plaintiffs / Applicants jointly through sweat and equity toll for over seven years to develop a new physical keyboard with 4 (four) shift keys and incorporated a new approach to keyboard layouts that allows for doubling the number of functions per keyboard on direct access typing.
 - (b) The driving force behind the invention is to allow for multiple languages typing without switching keyboard layouts.
 - (c) The invention avoided all the cumbersome processes used in typing extended Latin-character during regular typing, specifically, the use of Alt + number codes and Alt + Gr AltGr "dead key" typing process.
 - (d) The physical keyboard with 4 shift keys, unique keyboard layout and software driver together constituted a new keyboard technology invention. The invention and keyboard layout technique was used in creating multilingual keyboards for sale to end users.

The keyboard also has the following unique features:

it incorporates, in addition to the standard QWERTY keyboard, additional 14 extended Latin-characters, 13 combing tonal marks and 4 currency symbols on a single keyboard layout.
