
Novell will produce copies of its five largest OEM contracts and a list of OEMs. All such documents will be produced under the designation "Highly Confidential". These documents may be used by Microsoft's outside counsel pursuant to the previous Protective Order issued in this case, with the following conditions also imposed: The documents produced pursuant to this Protective Order may be shown only to Microsoft's outside experts and outside attorneys and may not be shown to any Microsoft employees, including without limitation, in-house or staff attorneys and other legal personnel such as paralegals. If any of the produced documents are to be used as exhibits in any depositions, these exhibits and relevant portions of the depositions must be sealed, and Microsoft must give warning to Novell before using them. If they are used as exhibits at trial, they must be sealed as well and not shown to Microsoft employees. Microsoft reserves the right to move the court to modify the Order issued to pursuant to this Stipulation, to allow in-house Microsoft attorneys and legal personnel to view the documents and will not be prejudiced in that motion by virtue of the execution of this Order.


