


Based on the parties stipulation, it is hereby ORDERED that Microsoft's Motion to
Compel Complete Production of Documents Obtained from Third Parties is granted, and that




Caldera shall produce unredacted copies of documents numbered INV001 through INV035 on or before December 23, 1998.


