
Caldera, Inc.'s Motion for Leave to Amend its Witness List and to Take Depositions came before the Court for hearing on November 10, 1999. James S. Jardine, of Ray, Quinney & Nebeker appeared on behalf of defendant Microsoft Corporation and Ryan E. Tibbitts, of Snow, Christensen & Martineau, appeared on behalf of plaintiff Caldera, Inc. The Court, having reviewed the memoranda submitted by the parties and having heard arguments of counsel, hereby rules as follows:

1. Caldera may add Adam Harris and Bill Mickel to its witness list as third-party witnesses.
2. Caldera may take the videotaped depositions of Mr. Harris and Mr. Mickel at a time and place mutually convenient to the witnesses and counsel.
3. The depositions may not exceed four hours, two hours per side.
4. Microsoft Corporation is allowed to add three more OEM witnesses to its witness list. These witnesses may be deposed by either Microsoft or Caldera under the same guidelines as in paragraphs 2 and 3, above, depending on whether the witnesses will appear live at trial or not.
5. Microsoft shall disclose to Caldera the names of any such OEM witnesses as soon as possible.
