Something is very very wrong around here. I was at Windows World in Chicago last week. In the main MS-Booth was a demo station that was demonstrating PowerPoint 3.0. On Friday I went poking around on \products1\beta, \products1\released, \products2\beta, \products2\released. Nowhere is a copy of this beta product. What is going on? We have a serious problem.

I did some more investigation, consulting with various sources, and sticking my ear to the ground and listening.

Data Results:

There is no plan to internally beta PowerPoint 3.0 inside Microsoft ever. This is over concern about leaks to the press about it.

PowerPoint 3.0 has been given only to the upper management folks and there is no plan to change this policy for the entire PP 3.0

release, PP 3.0

will be available generally inside MS when it is released to manufacturing and not before.

Rumor Results:

There is no need to beta this product. It will be wonderful by definition.

"All we get from corporate is a bunch of useless feedback anyway, so to hell with them. We don't need the aggravation of doing MS internal Betas.

This is totally consistent with PowerPoint's group attitude. They like to view themselves as a separate entity which is not subject to normal product rules and can do any old thing they want (including absorb MS corporate resources like \$\$\$\$).

The current PP 2.x product is inconsistent with the MS application group User Interface and inter-application communications standards and this is very unlikely to change. "You guys do it wrong and should do it like PowerPoint does anyway, your way is all messed up."

PP 2.x is a piece of garbage, looks like we'll have to live through another messed up release of this product before we'll be able to get things fixed.

I talked to David about what I think we (PS BU) need to be doing to end up with a successful proposal. Cairo has a lot of technology implemented. We need to evaluate whether what they have is appropriate; how much work does it need to be ship quality (including size, perf, etc.) and so on...

Obviously there are some strategic considerations as well (32-bit for NT synergy, getting our object model out there and established, etc.) but these need to be treated as individual (albeit important) factors in the overriding decision process. Not base assumptions.

We will meet with whoever is here today to talk to them about this process. It is absolutely critical that we get them bought in to both the process, and it's outcome.

THIS ISSUE COULD SNOWBALL INTO SERIOUS COMPATIBILITY PROBLEMS FOR WINDOWS NT,

COUGAR, AND WIN32S IF WE DO NOT ACT SOON.

I have been contacted by both Borland and Phar Lap about how to implement uncommitted memory in a VxD under Windows 3.1. I believe that unless we address this issue quickly, either by giving them Win32S, writing a VxD, or at least giving them guidance about how to implement it, they will go off and implement it, the apps that use their interface will be broken under future versions of Windows, and we'll have one hell of a nasty mess on our hands. They are also interacted in implementing on our hands. They are also interested in implementing mory mapped files.

| Both of these companies are interested in this technology for both DOS *AND* | Windows applications.

So, we need to do something about this - What? I don't know as much about

Win32S as I would like. Does Win32S implement uncommitted memory? If so, then we should use that VXD. If it does not then we may want to consider adding it. It could be hacked into 3.1 in the same way the load-hi VXD make UMBs work under 3.0.

If that's too much work, then we had darn well better give them some guidance so that they'll be compatible with NT and Cougar memory

managment. Perhaps under NT we could say that "These apps should just use the NT interface," but we need to make sure that these companies implement their services so that this is possible. Also, this will not address DOS apps, although I don't think 32-bit DOS apps are that important.

Suggested action:

In the best case, we're doing uncommitted memory for Win32S already and so we just clean up the VxD and give it to them.

Next best would be to write a VxD ourselves (with their input) that would implement the features they need. We could also use this for Win32S. We would make the VxD call the Cougar memory manager when running Cougar, and install hacks in 3.1 to provide uncommitted memory. I estimate that this VxD would require 1-2 man months to implement, although we may be able to use some of the Cougar code to speed up development. We strongly preach the NT interface for the exported API from their extender.

The worst-case option is just to give them guidance. We could give them the Cougar memory manager spec, give them some hints about what page tables to use, how to not conflict with eachother, etc. and let 'em party.

The unacceptable option is to do nothing. If we don't address this within a month or two I predict doom and gloom.

Experience has taught me that if you want something done right, don't ever let an ISV do it. I think that it is worth our time to write the VMD since it would give Win32S a great feature.

Brad, here are my recommendations on promotions for members of the Windows Test-Team:

Builder

Rick Emery - Currently D9, Promote to D10. Since joining Microsoft in July, 1991, Rick has come up to speed quickly on the Windows build environment. After 3-4 weeks of initial training, Rick has proceeded on his own with minimal supervision to automate and robustify the 3.1 build process. In addition to having an error free build process, Rick has demonstrated good technical growth as shown by his creation of automation tools to ensure clean builds each week.

Test Development

Richard Saunders - Currently D10, Promote to D11. Rich has been a key team leader for API and SDK/DDK testing. Under Rich's direction, he and his team implemented a test engine (RATS) and automated test suite to ensure stability of the core product components. Rich has demonstrated good technical and managerial growth during the review period. By assuming ownership and control of the SDK/DDK test process, Rich can always be counted on to follow through on all his assignments.

Mike Gibson - Currently D10, Promote to D11. Mike was the key test development engineer on Truetype testing for 3.1. Mike consistently developed high guality test tools/applications which were adopted by the TT developers for shaking out TT stability problems. Thoroughout the review period, I heard consistent feedback from development on the strength and quality of Mike's tests/testing. The overall quality of Mike's work contributed substantially to the quality of Truetype in 3.1.

Jeff Stewart - Currently D10, Promote to D11. Jeff has been instrumental in developing a test harness and architecture to reliably execute API tests across different platforms. In addition to the RATS engine, Jeff developed the API test plan/schedule for 3.1 and implemented tests for 3.1 API's and parameter validation. Through Jeff's work, most of it performed as a solo effort, the core API's of 3.1 were well tested and helped to increase the stability of the core components.

David Tryon - Currently D10, Promote to D11. David was instrumental in organizing and developing the PCT, DCT, and CT shell design for the Windows 3.1 project. David has demonstrated the ability to take a set of requirements (driver certification tests) and then work with several groups to produce a set of driver level qualification tests. Through David's hard work and good design decisions, the CT tests are in use by many third-party developers as a key tool in evaluating the quality of their drivers.

System Test

Kory Srock - Currently T10, Promote to T11. As system test lead, Kory was key in organizing and implementing a robust set of test suites to verify Windows 3.1 functionality. By working independently, Kory and his team developed a suite of MS-Test scripts that were executed on a wide variety of configurations to ensure 3.1 was solid. Kory's consistent results reports helped the management team evaluate quality issues with a high degree of certainty.

Mike Lipp - Currently T9, Promote to T10. During the review period, Mike was

instrumental in implementing the MS-Test acceptance suite. In addition, Mike was the lead display driver test engineer and developed a robust test suite to verify VDD/grabbers/drivers across the range of supported hardware.

Tess Aldinger - Currently T9, Promote to T10. Tess was the lead test engineer for ISV applications compatibility testing. Tess directed two temp engineers verifying the A/B list of applications using a standard set of test scripts. Tess established contact with her counterpart at many A/B ISV's and having this

technical relationship improved her overall effectiveness as an engineer.

Randy Gerl - Currently T8, Promote to T9. During the review period, Randy was responsible for developing and executing printer driver tests. Randy worked with

temp testers and a new hire guiding them on driver testing metods.

Overall, Randy has shown good technical growth, using exisitng test tools (PCT) and

developing automated suites to test our drivers.

Compatibility Test

Jody Germaine - Currently T10, Promote to T11. During the review period, Jody's leadership of performance testing, smartdrv.exe testing, ISV app bug tracking, and OS/2 compatibility testing was outstanding. For most of these projects mentioned, Jody worked independently to develop the plans, seeking input along the way. Jody's solid leadership and her good technical knowledge contributed substantially to the 3.1 effort.

Kevin Yim - Currently T8, Promote to T9. Since joining the Windows 3.1 last year, Kevin assumed ownership and execution of the 3.1 performance test suite. In addition, Kevin developed additional performance tests for common digs and 1 MB configurations. As Kevin has become a more independent worker, he assumed

test responsibility for WDL drivers and drivers are being tested in an efficient

manner.

Anne-Marie Arnold - Currently T9, Promote to T10. Anne-Marie assumed cwnership of the documentation for the Network Compatibility Test program, revising the documents and organizing them into an efficient and well written fashion. She also worked closely with corporate beta sites, assisting them with their Windows related network problems. She requires only limited direction in most of her activities.

Talal Batrouny - Ourrently T9, Promote to T10. Talal is an extremely hard worker and always put in many extra bours on evenings/weekends. He was always available to do additional work when asked. His knowledge of remote boot workstations greatly aided our Windows 3.1 testing in this area. Talal is an independent worker and can always be counted upon to complete an assignment in a timely manner with little supervision.

Additional information

This section of the Release Notes describes features of DR DOS 6.0 that are not explained elsewhere in the DR DOS 6.0 documentation.

Microsoft Windows 3.1

DR DOS 6.0 is fully compatible with Microsoft Windows 3.1.

The Windows 3.1 default drive for temporary swap files is the drive on which Windows was installed. If Windows is installed on a SuperStor drive it is recommended that users change the default drive for swap files to an uncompressed drive. This should be done for both temporary and permanent swap files. Use the 386 Enhanced option from Control Panel to change swap files.

If Super PC-Kwik is already loaded when you install Windows 3.1, you are informed by the Windows SETUP program that SUPERPCK.EXE is running and you are warned that your system may fail; ignore this message and continue with the Windows installation procedure.

Windows 3.1 makes changes to autoexec.bat and config.sys on installation. It is recommended that you make a backup of these files.

By default, Windows installs the SMARTDrive disk cache program and the HIMEM.SYS memory manager. However, the DR DOS 6.0 disk cache, Super PC-Rwik, and the DR DOS 6.0 MemoryMAI drivers provide superior functionality over the Windows 3.1 SMARTDrive disk cache and HIMEM.SYS. To use Super PC-Rwik and the DR DOS MemoryMAI drivers, instead of SMARTDrive and HIMEM.SYS, you simply remove one line from your autoexec.bat and config.sys files. Edit autoexec.bat to remove the line

C:\WINDOWS\SMARTDRV.EXE

and edit config.sys to remove the line

DEVICE-C:\WINDOWS\HIMEM.SYS

The above lines should be removed after Windows 3.1 has been installed but prior to rebooting.

If you are using the DR DOS 6.0 EMM386.SYS MemoryMAX driver, Windows may also replace the EMM386.SYS line in your config.sys file with the Windows EMM386.EXE line. As a result of this change, your system may generate an error message when rebooting. The EMM386 line should be changed back to its original form after installing Windows 3.1 for your system to boot properly. Refer to the backup of your config.sys to be sure that you have the correct syntax.

The Windows 3.1 installation will also insert a STACKS command into the CONFIG.SYS. Even though DR DOS does not use a STACKS command the line can be left in CONFIG.SYS. No error will result.

DR DOS 6.0 is compatible with both the SMARTDrive disk cache and with HIMEM.SYS. If you want to continue using these drivers, you must run the DR DOS SETUP program, and remove MemoryMAX and Super PC-Kwik. However, if you do use SMARTDrive instead of Super PC-Kwik, do not use the SMARTDrive + option to enable caching on a SuperStor compressed drive. Unexpected errors may result when this option is used.

ENM386.SYS supports upper memory for Windows 3.1 running in Standard or Enhanced mode. You no longer need to use the /WINSTD option on the ENM386.SYS command line to run Windows 3.1 in Standard mode.

NOTE: Machines that have LPT1 ports and are using NE2000 network cards configured for I/O address 360 have occasionally hung or had trouble running DOS applications under Windows 3.1. If this is encountered, try-setting the NE2000 for a lower I/O address.

Using Microsoft Windows 3.0 in Real mode

Note that before you load Windows in Real mode, you should ensure that upper memory (and additional memory created by the /VIDED option of EMEMB6.SYS or HIDOS.SYS) are disabled. Upper and Video memory are disabled by default, but you can also use the following MEMMAX command if necessary:

MEMMAX -U -V

LOCK and Microsoft Windows

You can use the DR DOS LOCK program, to temporarily lock your system, when you are running Microsoft Windows.

To install LOCK under Windows, do the following:

1. Load Windows and select the program group in which you want LOCK to appear (the ACCESSORIES group, for example).

2. Open the Program Manager File menu and select the "New" option. Then select "Program Item" in the dialogue box and press OK.

3. Enter "DRI Lock" in the "Description" field of the next dialogue box and "LOCK.EXE" in the "Command Line" field. Then press OK.

4. The LOCK icon, a red padlock, now appears in the program group you selected.

To use LOCK under Windows, do the following:

1. Click twice on the LOCK icon to run LOCK. Press the "Lock system" button to lock the system.

If your system is secure (that is, you have installed system security), your computer locks immediately. Enter your existing User or Master password to unlock it.

If your system is not secure, you are prompted for a password to lock it.

Note that if you want to hide the contents of your screen, select the "Hide Screen" option. The screen is restored when you enter the correct password.

Super PC-Rwik and Protected Mode Applications

If you get an "out of memory" error from protected mode applications such as Lotus 1-2-3 R3.1 or AutoCAD R11 (which use DOS extender technology), make sure that Super PC-Kwik is configured with enough reserved memory in SETUP or use the /R:nnnn switch with the SUPERPCK command.
