David,

I understand that you were probably just repeating back to the folks at AHP what you were told, but I hope you can help us get to the bottom of this. Using the customer as a leverage point into both of our organizations perhaps we can work this issue through.

GroupWise 5.1 does support the MAPI 1.0 service provider interface for Address Book, Message Store, and Transport Services. Outlook will not run properly on top of GroupWise 5.1 because it uses/expects unknown MAPI calls/parameters. We have asked our normal Microsoft contacts for assistance in getting this to work. To date the response has been that Outlook is using standard MAPI calls but at a much deeper level, and in fact they have admitted that they have not found any MAPI providers which do support Outlook. We have been unsuccessful at getting the additional information to add support for Outlook in our MAPI service providers. If you could champion this on behalf of AHP, perhaps we can get the information we need to make the customer happy.

There are two levels of information that we need assistance obtaining:

- 1) The basic MAPI interfaces utilized by the Outlook client for e-mail. This will help us to determine why the Outlook client is not currently working on top of GroupWise as an e-mail client.
- 2) The MAPI interfaces used to implement calendaring/scheduling. I'm pretty sure this is not part of the standard MAPI interface definition. If it makes sense, we'd like to give the GroupWise customer the option to use the Outlook client to access GroupWise calendaring/scheduling services.

Feel free to forward this message within your organization as necessary to get to the right people. Thanks for your assistance.
