IBM In the Joint Management Process, the agreed Plan Of Record cannot be changed unilaterally...WHG suggested that 20% of the development expense be at risk if LRR/JAC decide Microsoft has changed to plan unilaterally.

MS Unilateral change to the plan of record cannot constitute breach of contract.
