

- 3) If he had done x, y and/or z, it would have pushed his rating to a 4.0.
- 4) He can choose his manager for the coming review period either amit or david. He said he's perfectly comfortable w/ amit, but will think about it.
- 5) He and his manager will lay out in advance what he needs to do: x, y and z to get a 4.0 rating in the coming review period. If he follows through and achieves the 4.0, he will get promoted.

While I tried to stress the positive, I was also crisp about the negative feedback. I told him that I thought amit's criticisms in his review were valid, and that from my perspective, I would have liked to see him take a more global ownership of the project. For example, if he had no bugs in gdi to fix on a particular day, rather than stay home he could have come in and helped us chase down app compatibility bugs.

Like I said, we had a good talk and he came away feeling pretty good about the result. However, he said he has received offers from the publisher group and he wants to look at the particulars of the job they might offer him. I stressed that he should be just as open minded about what he could do here. If they offer him something that looks better than working on the dib driver (the current plan) perhaps we also can present a more attractive alternative. Most importantly, I stressed the importance of defining objectives in explicit detail with either Amit or David.

I think he needs a little more sell, but we should be able to keep him. One thing you might stress more is that he stands a much better chance of getting a promotion staying here than he would by moving.

That's all for now folks. Jeanp isn't here right now, so I'll probably save his review for Monday morning.

More negotiations with Rod Turner yesterday. I first told rod that I considered what he and gordon did to be an "old central point manuever" (agreeing to move forward awhile ago without a guarantee of knowing what would be in astro and then saying tuesday that they would have to know first).

However, as per a previous strategy bradsi and I worked out I told them about virus being likely for ms-dos 6. Rod was obviously concerned but did not opt for out of the deal. I did tell him i needed to get all the business terms resolved by Wednesday or I would use another of my back-up options. We have a conference call Monday and as one of the open issues is publishing the file format for their catalog files and the api for their dma driver I have asked mack to attend.

We did discuss the competitive restrictions clause for awhile and worked out the following compromise which I am hopeful will hold up:

## Definitions:

Superset product: defined as a norton product that contains back-up and/or the defragger but also contains other utilities (examples: desktop for ms-dos, desktop for windows, norton utilities.

Competitive OS - just like the contract reads now, a product that substantially represents the APIs of MS-DOS or Windows

## Agreement:

1. Norton may not integrate or bundle any superset product with a competitive OS until 6 months after we ship ms-dos 6. Norton may not integrate or bundle back-up or the defragger with any competitive OS until 12 months after we ship ms-dos 6.

Exception: Norton will not bundle or integrate back-up, defragger or any superset product with dr dos for the duration of the contract term.

2. Norton may bundle any product with an OEM at any time.

Exception: Norton may not bundle any superset product with a IBM machine shipping a competitive OS until 6 months after we ship ms-dos 6. Norton may not bundle back-up or the defragger with IBM machine until 12 months after we ship ms-dos 6.
