- The evaluation software we have is labeled "final beta".
 How do we know this is the RIM version? I don't want to have to repeat tests once we get packaged product. The RIGHT thing to do, before we go much farther, is get shrink-wrapped product here. Is it in-bound?
- 2. To do a full eval will probably cost us 2-3 test engineers and I don't want to defocus my net test team. If you want to sign up the dos test team for this, it will impact 5.0a setup and regression testing for AT IEAST 3-4 days, and probably
- I recommend we leverage xxxal/nstl for the bulk of the compatibility testing.
- 4. Jimla has installed and has not observed problems. We installed and found it would not run in standard more (under beta 2) and we corrupted a disk running in enhanced mode, but this is very preliminary data and should not jump to any conclusions. We installed



We frankly are hearing two sets of things on this — but latest is that yes, we will announce. Frankly it does make sense in that we have been fairly open about win 3.1 content (I think a lot of press think the mn extensions are already in the product; so they will probably ask us why we are ONLY shipping sound and media control...) It does create some challenges for mmsys message consistency since it puts a slightly different spin on our mm strategy and they have things pretty well laid down and set with OEMs and press that are following mm.

A couple of implications — we will build this into the demo (richt is doing) and presentation, and we need to amend a backgrounder on 3.1 that we did for the devleopers conference. This will happen next week early and we will keep you posted on what we are saying about this as additional product functionality.
