Dear Mr. Barrett:

Thank you for your letter dated November 1, 1991. I take it from your letter that you do not know who Roger Sour is, that there is no problem between the Windows 3.1 and the DR DOS 6.0 memory control blocks and that Microsoft has no intention of identifying the presence of DR DOS 6.0 so that Windows 3.1 will terminate itself or otherwise inconvenience the end-user because the end-user is running DR DOS instead of MS DOS. Please let me know immediately if my understandings are incorrect.

As I indicated in my letter of October 24, 1991, DRI tries to maintain a cooperative policy toward software manufacturers and to work with any software manufacturer that feels that something in our operating system is preventing its application from running well.

If, at any point, Microsoft detects a compatibility problem or potential problem between Microsoft Windows 3.1 and DR DOS 6.0, please call either myself or Byron Tomingas immediately to discuss the situation. To reach us dial the main switchboard (408-649-3896) and ask for either of us in Technical Support.


