Executive Summary

More than 130 editors and analysts from around the world attended the
Chicago reviewers workshop on May 12 and 13, including representatives from
all the major US trade publications and analyst houses. The workshop
consisted of two full days of briefings on all aspects of the product—from
architecture and the new UI to multimedia and international support—and
represented the "kick off" of the reviews cycle. The PR objectives for the
Chicago Reviewers Workshop were to:
o Educate editors on all new features and functionality in chicago such that
they could write comprehensive first looks reviews immediately and have
context for final and competitive reviews once product ships

context for final and competitive reviews once product ships o influence perceptions of new features prior to receipt of M6 code o Shape review criteria

We clearly met the first two objectives— attendees commented that they were blown away by the breadth of material covered over the two days and felt much more informed about the new features and functionality in Chicago. Additionally, almost all had positive comments with regard to what they had seen and heard. Although the task or influencing review criteria was initiated at the workshop, this will be a continuous process throughout the development cycle. Once editors and analysts receive bets code, have a chance to look at it themselves and formulate the reviews, we will have a chance to more directly impact review criteria.

All attendess were impressed with what they saw of Chicago. The most common-comment was, "If Microsoft delivers on it +e promises, +Chicago + will be a tremendous product." Many went on to say that there is no apparent competitor to Chicago, that it is in a class of its own. These are strong comments coming from an audience that prides itself on objectivity and present accomment to the price of the price prefers to reserve comment until after they have had a chance to look at a product in their own labs.

Based on the content of the workshop, many of the publications are now planning their "First Looks" reviews. Incredibly, PC/Computing felt that planning their "First Looks" reviews. Incredibly, PC/Computing fert that the material presented was comprehensive enough that their "First Looks" review will be based on the material presented at the workshop and one hour of hands-on time at the end of workshop. Their review is scheduled to appear as a cover story in the July issue. Additionally, PC World, who was originally planning to wait until September or October issues to run a "First Looks" review, has decided that "Chicago" is too cool to wait. They are now planning to run a review in the August issue.

gave the workshop an overall rating of either a "4" or "5" on a 1-5 scale), many would have perferred that more time was allotted to demos and Q&A. Many commented that the presentations were a bit too long, at the expense of Q&A time. Also, many felt the breakout sessions were helpful and would have liked to have more.

Larry Saltzer, PC Week Labs: "What's not to like about the Chicago UI. I like that Start button!"

Bernd Harzog, Gartner Group: "Now MS will have IS on their side. You've always had users on your side, now you have the other side of the house. And, networking has always been too hard. I like the way you've integrated it."

Chris Barr, PC Magazine: "The UI looks good, i+m really impressed. What we+re most worried about is the performance. We have 16-bit systems and it will be interesting to see once we get code."

John Ruley, Windows Magazine: Refused to say that he was getting good, updated technical information. Said there weren't enough demos. Said there was not enough time for q&a. Said the UI wasn't really different from M5 shown at the PDC. (John tends to be a contrarian, particularly when he feels he can+t be objective, le no code to look at on'his own. PR will be working with John closely to ensure all issues wit Chicago are addressed)

Michael Miller, PC Magazine: Seemad very genuinely impressed. Should expect to continue getting lots of technical questions, especially related to OLE and the UI. He's a big OLE fan.

Steve Gibson, Gibson Research: "You've done so much. Really really impressive."
