> * Until July, Acer can still submit new systems for the Designed

> * If Acer is working now toward testing and building drivers

> early and pass, they can receive the artwork for the new combined Logo
> before Memphis ships so they might be able to get it on Aspire 5 for
> the fall, if that is something they are interested in.
> * After July, Acer should focus on testing to Memphis and Windows
> NT 4 and 5. WHQL will be doing testing starting very soon against
> Memphis beta and Win NT 5 beta, so those are the platforms (and
> drivers) Acer should be focusing on, certainly for the July onward
> timeframe (or once NT 5 beta 1 ships).
> * Regarding device drivers for Windows NT 4.0, there is a large
> list of devices that are listed on the current Windows NT 4.0 ECL (see
