Hi Bill,

This is Kyle Faulkner here, the CTO at Instant Video Technologies. For the previously scheduled meeting, I worked with Will Friedman to ensure that we would be able to demonstrate our software over the Internet as part of this demo. Since we use some TCP/IP ports (8018 through 8021) I believe your firewall is not currently configured to allow these ports and so it is blocked. Will was going to have the meeting in a conference room where this would not be an issue and I wanted to make sure this is still the case. Is it?

To ensure that there are not last minute issues I would like to ask you to actually run our demo and let me know that it worked successfully and also what your measured bandwidth to the servers were. This is all pretty self explanatory when you run the demo.

Running this URL will cause an embedded control to install a WMP source filter to burst enable the WMP and the associated registry entries. Our demo pages also have a Java applet based on our player SDK which is downloaded to check the bandwidth to the servers to enable content at an appropriate bit rate. These are both signed applications and are downloaded via embedded controls in the web page in a standard way.
